Dear Dr. McKelvey:

May I acknowledge your letter of Feb. 14 which raised a number of questions that I would like to discuss with you today. I hope you allow me to go direct to the point wishing at the same time that I don't become unpolite with my frankness.

1. May I ask in the first place something about the lists which were sent with my letters of Aug. 22/56 and Jan. 20/57. Since you did not mention anything about the lists that did not involve Mr. Kolb I would appreciate having a word about them if you are kind enough to care about it. This question leads to another one which is whether you have set any rules as to how much allocation The Rockefeller Foundation has decided to offer for any year of the proposed three-year period. How much would you say it to be proper to expect in a given year? Usually what percentage should be expected to go into shipment, taxes, fees, etc? Would it be all right to start the process of preparation of new lists for 1957?

With the aim of better clarifying re our lists sent in 1956 you will find a new summary with this letter from which items corresponding to Mr. Kolb's order were eliminated.

2. As for your discussion regarding the proposed salary supplementation I am now in the process of collecting some data to present to you as support to my argument that the situation has not changed much in relation to Rio and São Paulo conditions.

3. I believe it would interest you to know that we are now about to receive a set of promissories on a total corresponding to the first third of the three installments to be paid by Minas Gerais to our school as part of the total amount of 10 million cruzeiros that should match your grant.

As for the second installment, enclosed you will find a copy of my request to the Secretario das Finanças for a payment of R\$ 3.333.333,30 as approved and included in the included in the State Budget for 1957.

4. I have written to Messrs Brito and Murgel indicating the possibility that their applications would not be approved for the reasons you pointed out to me. Thus far no answer came.

But two other students came to my office to ask whether I would write to you about their wishes. They want to be candidates for 1958 to a Rockefeller fellowship. They have already accepted to work with the ACAR organization which agreed with their plans but requesting (a) that they attend their short training program before they should go into yours and (b) that they return to their ACAR jobs after your training program is over. Evidently extension is their main interest.

5. May I use this opportunity to ask for your support to Mr. Giudice's application for a Rockefeller fellowship which was already sent to you? He is planning to go to Purdue and to have a graduate course in electricity, electronics and meteorology (what we call "rural physics"). Mr. Giudice is a hard working person, very helpful to my administration and very serious about his line of work both within and outside this school. To my mind he is a person who very well deserves a chance of improvement in your Country.
